The following information pertains to the 2018 National Simmental Sale held in conjunction with the Southwestern Exposition and Livestock Show on January 27th, 2018.

Show Entries:

- A. All entries must be Purebred Simmental, Simmental Percentage (50% or more), or purebred Simbrah and registered with the American Simmental Association. All entries will be subject to Progress Through Performance guidelines and Texas Simmental/Simbrah Association guidelines.
- B. The original registration certificate for each entry must be available for presentation to the superintendent or manager of the show at the time of entries are verified prior to judging.
- C. Two year old heifers must have produced a calf or be safe in calf as verified by a licensed veterinarian, or have been used as a donor female and have produced viable, fertilized embryos as verified by the owner.
- D. No calf, either heifer or bull, can be shown at the side of the dam, if older than 205 days on the day of the show.

Seller **MUST** enter all sale cattle in the show in order to be eligible to enter the Southwestern Exposition facilities. The entry deadline for the show is **November 15th, 2017**. The staff at the Southwestern Exposition and Livestock Show management has requested that all sellers/exhibitors must enter their own sale cattle in the show. Sale Nominations:

The nomination form for the National Simmental Sale can be downloaded at www.innovationagmarketing.com. This form must be filled out and returned to the office no later than **October 15th, 2017**. ***(In order to have information to cross reference entries. Sale animals MUST be entered in the show in order to be allowed on the grounds.)*** In addition to the form, please submit your sale photos and any supplement photos to the office via email or Dropbox.

Special Notes:

All genetic nominations are subject to a screening.
All sale cattle must be halter broke in order to be brought onto the grounds.
All sale cattle must have proper health documentation in order to be sold.

Health Requirements:

SALE CATTLE

Cattle that are consigned to the sales, sold, leased, exchanged, gifted, or otherwise under change of possession at the Southwestern Exposition and Livestock Show;

TEXAS ORIGIN

- A. Certificate of Veterinary Inspection issued within the past thirty (30) days.
- B. Must have approved identification for cattle; official breed registry tattoos or firebrands or USDA approved tags. Contact Texas Animal Health Commission for more information.
- C. Breeding bulls must be either eighteen (18) months of age or younger and certified as a virgin or be tested negative for Trichomoniasis within the past thirty (30) days.



OUT OF STATE ORIGIN

- A. Certificate of Veterinary Inspection issued within thirty (30) days of entry into Texas and/or show grounds.
- B. Must have approved identification for cattle; official breed registry tattoos or firebrands or USDA approved tags. Contact Texas Animal Health Commission for more information.
- C. Breeding bulls must be either less than twelve (12) months of age or be tested negative for Trichomoniasis with an official Polymerase Chain Reaction (PCR) test within the past thirty (30) days.
- D. All breeding age bulls twelve (12) months of age or older must present proof of passing a Breeding Soundness Exam (BSE) within a thirty (30) day period leading up to the sale. Documentation required at check in.
- E. All bred cattle must have pregnancy status stated on health certificate in month or day. Documentation required at check in.
- F. Cattle from Idaho, Montana, and Wyoming require an Entry Permit.
 - a. Prior to entry permits are required as noted for specific classes of livestock. Permits may be obtained by calling (512) 719-0777, (800) 550-8284 EXT. 777, or by writing the Texas Animal Health Commission, Attention: Permit Department. PO BOX 12966, Austin, TX 78711-2966

Supplement Information:

There will be an update sheet created, for sale day, containing any additional information needed. Please provide any additional updates to Graham Blagg by noon on January 25th.

Other Information:

- A. Sale tags will be provided upon check-in.
- B. All cattle must leave the sale location by Sunday, January 28th, 2018. There will be a possibility that you will need to take your own cattle back to your farm/ranch and arrange shipment from there if they are not loaded out on sale day.
